SPECIFICATIONS

Each artist may submit up to two works. One painting per artist will be included in the show. The second painting will be included space permitting and at the discretion of the judge.

No entry may exceed 720 square inches. Digital and slide entries are not accepted.

ENTRY FEE

\$30 entry fee for up to two paintings. Fee will be collected at drop off. There is no preregistration.

ELIGIBLE WORKS

Paintings must have been completed within the past two years and should represent your best plein air effort. No wet paintings allowed. (Reminder: "plein air" painting is completed outdoors.)

FRAMING

All work must be properly framed. We will not be responsible for works damaged through faulty wiring or framing. Use flat strap wires only (no saw-tooth or clip frame hangers). Works on paper must be glazed.

INSURANCE AND LIABILITY

All works must have a value listed for insurance purposes. Indicate the insurance value of all entered works, including those not for sale. Values must be based on actual retail sales, subject to a maximum of \$5,000 for any one item.

SALES

Sales are strongly encouraged. Artists will receive 60% for each painting sold. Commission will be split between IPAPA and the Art Association of Henry County. Prices on the entry form should reflect this commission. Sales tax payment is the responsibility of the artist. The art association does NOT collect sales tax.

Accepted works may not be withdrawn prior to the close of the exhibition.
